

Odluka o određivanju pušačkih i nepušačkih zona

Na osnovu člana 11. Zakona o zaštiti stanovništva od izloženosti duvanskom dimu („Službeni glasnik RS“, br. 30/2010), privredno društvo BW Kula .d.o.o. Beograd – Savski Venac, Karađorđeva 48, 11000 Beograd, matični broj: 21318256, PIB: 110216370 (u daljem tekstu: Društvo),

dana _____ godine donosi sledeću:

ODLUKU

o određivanju pušačkih i nepušačkih zona u objektu vidikovac 360 Belgrade Deck

U cilju zaštite zdravlja zaposlenih, posetilaca i gostiju vidikovca 360 Belgrade Deck na adresi Nikolaja Kravcova 1/1A, Beograd (u daljem tekstu: Objekat), kao i osoba koje povremeno ili privremeno borave u objektu, u smislu odredbi člana 8. Zakona o zaštiti stanovništva od izloženosti duvanskom dimu (u daljem tekstu: Zakon), zabranjuje se pušenje u svim javnim zatvorenim prostorima i mestima rada u Objektu. Shodno definiciji pojmova u smislu odredbe člana 2. Zakona, pod javnim prostorom smatraju se svi prostori za kretanje posetilaca i gostiju, odnosno svi restorani, barovi, hodnici, liftovi, i druge prostorije u okviru Objekta. Pod mestima rada u Objektu, smatra se svaki prostor koji koriste zaposleni u Objektu za obavljanje poslova iz svoje nadležnosti (kancelarije, toaleti, hodnici, sala i ostalo), kao i službena vozila. Pušenje je dozvoljeno isključivo u prostorima, koji su posebno obeleženi kao “Pušačke zone”, odnosno na.

_____ Ove zone su usklađene sa zakonskim zahtevima. Sve pušačke i nepušačke zone biće jasno obeležene odgovarajućim oznakama, koje su postavljene na vidljivim mestima u skladu sa zakonskim standardima. Kontrola sprovođenja ove odluke biće poverenalicu/licima imenovanim Odlukom o imenovanju odgovornog lica za kontrolu zabrane pušenja koje je zaduženo za nadzor, usmenu opomenu prekršioca i sprovođenje mera u skladu sa zakonom.

Ova odluka stupa na snagu danom donošenja i biće dostupna svim zaposlenima, posetiocima i gostima. Njeno sprovođenje je obavezno za sve posetioce, goste i zaposlene u privrednom društvu BW Kula d.o.o. Beograd – Savski Venac, Karađorđeva 48, 11 000 Beograd, matični broj: 21318256, PIB: 110216370.

Pursuant to Article 11 of the Law on Protection of the Population from Exposure to Tobacco Smoke (“Official Gazette of the Republic of Serbia,” No. 30/2010), the company BW Kula d.o.o. DECISION

on the designation of smoking and non-smoking zones in observation deck 360 Belgrade Deck

In order to protect the health of employees, visitors, and guests of observation deck 360 Belgrade Deck, located at Nikolaja Kravcova 1/1A, Belgrade (hereinafter referred to as: the Property), as well as individuals who temporarily or occasionally stay in the Property, and in accordance with the provisions of Article 8 of the Law on the Protection of the Population from Exposure to Tobacco Smoke (hereinafter referred to as: the Law), smoking is prohibited in all enclosed public spaces and workplaces within the Property. According to the definition of terms as per the provision of Article 2 of the Law, public spaces are considered to include all areas for the visitors and guests, such as restaurants, bars, hallways, elevators, and other premises within the Property. Workplaces within the Property are considered to include any area used by employees of the Property to perform their duties (offices, restrooms, hallways, meeting rooms, etc.), as well as company vehicles. Smoking is permitted exclusively in areas specifically designated as “Smoking Zones,”

at _____ These zones are in compliance with legal requirements. All smoking and non-smoking zones are clearly marked with appropriate signage, placed in visible locations in accordance with legal standards. The enforcement of this Decision will be entrusted to the individual(s) appointed by the Decision o the Appointment of the Responsible Person for Monitoring the Prohibition of Smoking, who will be responsible for overseeing compliance, issuing verbal warnings to violators, and enforcing measures in accordance with the law.

This Decision becomes effective on the date of issuance and will be made available to all employees, visitors and guests. Its enforcement is mandatory for all visitors, guests and employees of BW Kula d.o.o. Beograd – Savski Venac, Karađorđeva 48, 11000 Belgrade, Company Registration Number: 21318256, TIN: 110216370.
